# BOND PROJECTS BEGIN IMPLEMENTATION

The evolution of personalized learning in Fraser Public Schools will take a step forward this fall with the first major purchase of the May 2 bond. The Board of Education unanimously approved the purchase of new MacBook Airs and iPads for students in June. All students at Fraser High School will receive a MacBook Air laptop instead of an iPad going forward. Students in grades 3-8 will receive new iPads, and students in DK-2 will receive iPads purchased in 2015.

"This fall all Fraser High School students will receive a laptop, which will allow them to both consume and produce work at a higher level," said FHS Principal Dr. Michael Lonze. "This change in devices not only supports our movement towards personalized learning for each student, it also supports the college culture that we are instilling in our students."

The devices are scheduled to be deployed during the first week of school.

Students were interviewed as the list of bond projects was developed. At FHS, they overwhelmingly preferred a laptop to the iPad. The high school currently has 210 MacBook Air laptops for classrooms and students to check out. An analysis of their usage showed that they were in use 80 percent of the time.

"Our students and teachers are already familiar with MacBook Airs. Everyone having their own laptop will support our transition to a competency based learning model, will allow students to work more efficiently, and keep up with increased rigor," said Assistant Superintendent of Curriculum and Instruction Carrie Wozniak.

On the construction side, several bids were awarded for work at both Richards Middle School and FHS. The leaking roof over the 80s wing and art wing at RMS will be replaced, as well as installation of new clocks throughout the school and improving the cafeteria sound system. At FHS, a new scoreboard and improved sound system at the football stadium will also be installed before the first home game on August 31. The lights in the older portion of the cafeteria will be replaced with more energy-efficient lighting.

# RST DAY OF SCHOOL

As Fraser Families gear up for the start of the 2017 School Year, it is important to begin thinking about our school year routines.

We want to ensure our children begin school with a positive mindset, support their transition into a new school year, and prepare them for fall learning.

The last few weeks in August are a good time to begin preparing for the start of the year. Consider some of the following Back to School

## **EASE INTO THE ROUTINE**

Switching from a summer to a school schedule can be stressful to everyone in the household. Avoid first-day-of-school disorder by practicing your routine a few days in advance. Set the alarm clock, go through your morning routines, and get in the car or to the bus stop on time. Routines help children feel comfortable, and establishing a solid school routine will make the first day of school go much smoother.

## IT STARTS THE NIGHT BEFORE

Is your child getting enough sleep? Mornings are bound to be harder if your child is overly tired. A sleepy child of any age won't function at his or her best, so work backwards from your fixed morning deadline (school start, daycare drop-off, work arrival) to determine when your child should be in bed.

# **CONNECT WITH FRIENDS**

A familiar friend can make all the difference when heading back to school. You might try calling parents from last year's class and finding out which children are in your child's class this vear. Refresh these relationships before school starts by scheduling a play date or a school carpool.

## **DEVELOP GOOD HOMEWORK AND STUDY HABITS**

Create an environment that is favorable to doing homework starting at a young age. Children need a consistent work space in their bedroom or another part of the home that is quiet, that is without distractions, and that promotes study. Create a schedule that allows ample time for homework. You could build this time into choices about participation in afterschool activities.

# FIND YOUR CHILD'S BUS STOP ONL

Bus stop information will be available online for the 2017-2018 school year starting August 26. You can access your child's bus stop information by visiting www.fraser.k12.mi.us or by visiting your child's school website. Click on the "My Child's Bus Stop" link and enter your address to retrieve your child's bus stop information. It is very important to check your child's bus stop, as routes have been modified for the 2017–2018 school year.

Students will be assigned a route number in lieu of a bus number. The route number is located on the left side of the entry door. Each bus route has been assessed and tested in an effort to make Fraser's transportation system as safe and efficient as possible. To ensure transportation, all students must be at their bus stop 10 minutes prior to the bus' scheduled arrival time. To ensure a safe and pleasant ride, please review with your child the bus rules found on the Transportation Department's website.

# FRASER HIGH SCHOOL **PARKING PERMITS**

Only students with permits may use parking lots on school grounds during the school day. Annual permits may be purchased for a nonrefundable fee of \$40. Permits are color-coded and issued for a specific lot each school year. Permits will be available during orientation.

# FRASER EDUCATION FOUNDATION ENHANCES EXPERIENCE FOR ALL STUDENTS

Critical thinking and problem solving are important skills at the center of learning in Fraser. 21st Century Literacy Teacher Kristi Skladanowski wanted to create an environment in her classroom at Edison Elementary where students could develop those skills while collaborating and having fun. But the Makerspace she envisioned required resources that were beyond the normal school budget. Last fall, Mrs. Skladanowski turned to the Fraser Education Foundation and requested a mini grant.



Since its establishment in 1987, each year the members of the Foundation review grant applications from district staff for a variety of projects that offer student enrichment, teacher creativity and community involvement. The tax-deductible organization provides funding for projects, activities and classroom materials that go beyond the scope of normally funded school budgets and responsibilities.

The Foundation's grant program supports funding at all levels, DK–12th grade, through single grants (\$2,000–3,000) and mini grants (up to \$1,000). During the 2016–2017 school year, the FEF awarded a single grant to the stagecraft class at Fraser High School. The \$2,975 was used to add a lighting unit to the class, giving students an opportunity to learn to set-up, program and design multiple lighting effects for the theater. They also funded three mini-grants for the purchase of the Makerspace for Mrs. Skladanowski at Edison, as well as a Makerspace for Tanya Leon at Richards Middle School and Ozobots for Christina Sorrow at Salk Elementary.\*

With the \$1,000 mini grant, Mrs. Skladanowski purchased Ozobots, Bloxels, gravity mazes and critical thinking/problem solving games. She wanted to offer activities that were built around STEM/STEAM that can be adapted for students in every grade.

"The students are excited about using these new resources, and I am very grateful for this opportunity to share with my students," she said.

# Transportation Supervisor Wins Countywide Award

Transportation Supervisor Steve Burnett was recently honored as the Transportation Official of the Year for Macomb County. His peers selected him after his instrumental role in forming a Macomb County Train the Trainer program.

"I never expected my peers to choose me. I couldn't wipe the smile off my face; I was very humbled," he said.

Train the Trainer is a program for bus driver trainers from surrounding districts to work on professional development, learn from each other, and share best practices. Trainers then take the information back to their districts and share with the rest of the drivers. Before establishing the Macomb County group, trainers were traveling to Oakland County to share ideas, concerns, tips and information with each other.

"Supervisors and Directors rely on trainers to prepare new drivers for the task of safely driving students to and from school. We also count on trainers to keep current with new laws, training procedures, testing procedures and changes to the DOT regulations."

# WE ARE FRASER. WE RISE

In the fall of 2016, several coaches, former student athletes and the athletic director created a coaches council to determine how to unify and energize the department, programs and student-athletes. The group developed three things: a new Rambler logo, a department slogan, and the framework for a leadership academy for student-athletes.

The new Rambler logo will replace the various logos that have evolved over time with a cohesive and refreshed look. It symbolizes the future of athletics.

The department slogan, "We are Fraser. We RISE" is the result of several Coaches Council meetings and the help of an outside consultant. RISE is an acronym for Resilience, Integrity, Sacrifice and Excellence. The goal was to create a phrase that would represent the department, all coaches and, most importantly, all student-athletes.

Finally, the Council created the framework for the RISE Academy — a leadership academy for students from every grade and every sport. In May, students spent the day learning from guest speakers, coaches and each other to develop the leaders within the programs.

Follow-up meetings are planned for August and will continue every month. Once the process is developed at FHS, it will be incorporated at Richards Middle School.



"Our intention is to introduce the program at the middle school level, so that the transition to high school has begun before students walk in to FHS," said Athletic Director Shane Redshaw.

Posters and murals are already posted around FHS — in the hallways and weight rooms. More will be incorporated as the athletic facilities are upgraded with the bond projects.



# THE GRIEVANCE PROCEDURE IS ESTABLISHED TO MEET THE REQUIREMENTS OF TITLE II OF THE AMERICANS WITH DISABILITIES ACT OF 1990, TITLE VI OF THE EDUCATION AMENDMENT ACT OF 1972, TITLE IX OF THE EDUCATION AMENDMENT ACT OF 1972, SECTION 504 OF THE REHABILITATION ACT OF 1973, AND THE AGE DISCRIMINATION ACT OF 1975.

Section I: Any person may use this grievance procedure to file a complaint of discrimination on the basis of race, color, national origin, sex, disability or age in the programs or activities that are provided by Fraser Public Schools. The grievance may be brought forward to the Local Civil Rights Coordinator, who is identified by name and job title as:

**Section II:** The person who believes he/she has a valid basis for grievance shall discuss the grievance informally and on a verbal basis with the local Civil Rights Coordinator, who shall, in turn, investigate the complaint and reply with an answer to the complainant. He/she may initiate formal procedures according to the following steps.

Step 1: A written statement of the grievance signed by the complainant shall be submitted to the Local Civil Rights Coordinator within five (5) business days of receipt of answers to the informal complaint. The Local Civil Rights Coordinator shall further investigate the grievance and reply in writing to the complainant within five (5) days.

Step 2: If the complainant wishes to appeal the written decision of the Local Civil Rights Coordinator, he/she may submit a signed statement of appeal to the Superintendent of Schools within five (5) business days after receipt of the Coordinator's response. The Superintendent shall meet with all parties involved, formulate a conclusion, and respond in writing to the complainant within ten (10) business days after receipt of the coordinator's response.

**Step 3:** If the complainant remains unsatisfied, he/she may appeal through a signed, written statement to the Board of Education within five (5) business days of his receipt of the Superintendent's response in Step 2. In an attempt to resolve the grievance, the Board of Education shall meet with the concerned parties

and their representative within forty (40) days of the receipt of such an appeal. A copy of the Board's disposition of the appeal shall be sent to each concerned party within ten (10) days of this meeting.

**Step 4:** If at this point the grievance has not been satisfactorily settled, further appeal may be made to the Office for Civil Rights, Department of Education, 600 Superior Avenue East, Suite 750, Cleveland, OH 44114.

Inquiries concerning the non-discrimination policy may be directed to Office for Civil Rights, Department of Education, 600 Superior Avenue East, Suite 750, Cleveland, OH 44114.

The local Civil Rights Coordinator, on request, will provide a copy of the District's grievance procedure and investigate all complaints in accordance with this procedure.

A copy of each of the Acts and the regulations on which this notice is based may be found in the Local Civil Rights Coordinator's office.

# **AHERA (ASBESTOS HAZARD EMERGENCY RESPONSE ACT)**

The Environmental Protection Agency has determined that airborne asbestos fibers can be a health hazard. The Asbestos Hazard Emergency Response Act (AHERA) was passed in 1986. District buildings are monitored every six months and inspected every three years to comply with AHERA regulations. The last inspection was completed in 2016. Updated Management Plans are located in the office of each building and in the Operations & Maintenance Building. Each Plan shows asbestos-related work that has occurred in each building.

# REPRODUCTIVE HEALTH AND SEX EDUCATION INSTRUCTION – STATE AID ACT, 1766A

The Board of Education has established a program of health instruction which includes reproductive health and other sex education instruction, as well as serious communicable disease prevention education.

According to applicable law, parents/guardians have the right to review materials or observe classroom instruction; please contact your student's school principal.

This statute also allows you to excuse your child from participation in classes which include such instruction, if you choose. If you wish to exercise your right to excuse your student from this instruction, please send written notice to your student's school principal.

# **BADGE SYSTEM FOR VISITORS, VOLUNTEERS AND GUEST TEACHERS**

For security purposes, the District is continuing its practice of requiring all visitors, volunteers and guest teachers to wear an identification badge while in any school building. All persons entering a school building are requested to immediately report to the main office to obtain an identification badge.



# **FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)**

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that Fraser Public Schools, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Fraser Public Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Fraser Public Schools to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

**Directory information**, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with the following information — names, addresses and telephone listings — unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Fraser Public Schools to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing by the end of the second week of the school year. Fraser Public Schools has designated the following information as directory information:

- Electronic mail address
- Photograph
- Participation in officially recognized activities and sports
- Degrees, honors and awards received
- Major field of study
- The most recent educational agency
- Dates of attendance and institution attended
- Grade level
- Student ID number, user ID, or other unique personal identifier used to communicate in electronic systems that cannot be used to access education records without a PIN, password, etc. (A student's SSN, in whole or in part, cannot be used for this purpose.)

# **DRUG-FREE SCHOOLS**

# Drug-Free Schools and Communities Act of 1996 (amends Michigan Public Health code) Public 174 of 1994

The "drug-free zone" surrounding school property is 1,000 feet. Any individual who delivers cocaine, narcotics or certain other illicit substances to a minor student within the 1,000-foot drug-free zone around the school property shall be punished by at least two years in prison and up to three times the term of imprisonment and fine — or both — that would otherwise apply. "School Property" is defined as a "building, playing field or property used for school purposes to impart instruction to children in kindergarten through grade 12, when provided by a public, private, denominational or parochial school, except those buildings used primarily for adult education or college extension courses."

# PEST MANAGEMENT PLAN

Dear Parent/Guardian: As a part of the Fraser Public Schools Pest Management Program, pesticides are occasionally applied. You have the right to be informed prior to any pesticide application made to the school grounds and buildings. In certain emergencies, pesticides may be applied without prior notice, but you will be provided notice following any such application. If you need prior notification, you may notify the school district in the following ways:
