Dr. Delgado and Ms. Barla spoke about Fraser's plan for the grants, if the district is awarded them. A presentation at a Board meeting was a requirement of the application process for the 98c grant. Fraser would use the money for additional at-home apps and programs, materials for before- and after-school tutoring, resources to address elementary literacy deficits and expansion of secondary level digital literacy resources.

Potential ideas for the 31aa grant would be to create an elementary behavioral interventionist, expanding restorative practices and provide trauma-informed training for staff. 31aa requires funds be used for new practice or strategy to address mental health.

Irene Bariatakis – Disney parent and employee. She lives very close to Disney. Why are our students not being protected? There is an angry parent parked across the street who is getting preferential treatment to have her students walked to her car. I don't feel safe with my kids walking home or being at school.

Molly Magnotte – Thank you to Dan Waters for the help in the parking lot, it is running much smoother. She asked if there could be a guardian code of conduct for the district that explains how adults should behave on district property. I think there should be more transparency about school board meetings, maybe add links to the grants or projects talked about during meetings.
